- Question: what is a comfortable number of fundraisers for this year? What do we want to raise money for? Stacey & Judy have some ideas- design lab & outdoor learning space. The financial needs will develop over time. Also increasing our devices so we can get kids on technology. Chromebooks. We can discuss after the casino. Suggestion to do fundraisers seasonally, so maybe 4 fundraisers in the year.
- Budget Discussion for Admin, teachers and Education- we have historically given the teachers money for their classrooms. Last year we gave them each \$150, and EA's \$50 each (used for stickers, books, toys, etc). We approve for the same amount this year. Also we would like to contribute toward the 'treasure chest' for the office admin- this will be rediscussed around Christmas when the chest gets low on toys. Stacey asks for money towards gingerbread houses at Christmas. Plan to have a budget planning meeting to discuss gingerbread houses and other events through the year
- Casino November 7, 8. We have a few volunteers currently. We will need 11 people per shift, and there are 4 shifts.
- Insurance- we have to fill out another application because the division is shopping around for a new provider
- October 4- our annual general meeting where we have elections. Every position will be up for election. Now that we have bylaws we can be audited. We will need 2 volunteers

- next month to arrive early to approve the treasurers audit and sign off.

Potentially can add cougar wear down the road.

Parents in the room are advocates for the home cooked meals. Jody explains a bit about the labor requirements for that. Barb suggests beginning with takeout and bringing in cooking after the first session. Agreed that volunteers get their lunch as a reward for cooking. Pricing will be researched. Suggestion to survey parents on what they'd like for pricing (set hot lunch price or variable depending on what is served). Fiona will look into whether or not she can deliver a survey through hotlunches.net
