

### ANNUAL ASSURANCE ACTIONS

#### Background

Foothills School Division is committed to the Assurance model in engaging with its schools and communities to inform decision making and strategic planning. Key to this approach is alignment of actions across the Division that promote the Engagement, Support and Success of each Learner. The actions outlined below are annual commitments that will ensure our school and Division communities that our students are well served today and into the future. These actions are aligned with Alberta Education's Business Plan as well as the Division's policies, Strategic Directions and Education Plan.

#### Definitions

**Assurance** means demonstrating to Albertans that the education system is meeting the needs of students and students are successful. **Assurance** arises from the combination of funding, policies, processes, actions, and evidence that help build public confidence in the education system. **Assurance** is achieved through relationship-building and engagement between all education partners and by creating and sustaining a culture of continuous improvement and collective responsibility. (Alberta Education Funding Manual 2021/22, p. 156)

#### Planning and Reporting Process

Foothills School Division's planning and reporting processes reflect the guiding principles, domains and processes outlined in Alberta Education's Assurance Framework. Our effective planning and results reporting occurs in a continuous improvement cycle which is integral to our accountability and assurance. Division and School Education Plans and Annual Education Results Reports (AERRs) are products and evidence of a continuous improvement process and are core documents for demonstrating accountability and providing assurance. Our FSD strategic Planning Process is outlined in FSD [Administrative Procedure 100: Three-Year Education Plans and Annual Education Results Report \(AERR\)](#) and [AP 101: Annual Education Results Report](#).

Our Three-Year Fixed Term (2021-2024) Education Plan sets out what needs to be done, including determining priorities, outcomes, measures and strategies using the most recent results and is aligned with the strategic direction of [Alberta Education's Three-Year Business Plan \(2020-2023\)](#). Our AERR provides the results obtained from implementing the plan and actions taken to meet responsibilities in the key assurance domains. Our Education Plan clearly identifies priorities and outcomes to be achieved, measures used to assess progress, and research and practice-informed strategies implemented to achieve our goals.

FSD has established a system of accountability and assurance for its individual schools that enable continuous improvement and evidence-informed decision making. There are clear connections between school and Division plans. The Division priorities and assurance framework provide strategic direction to schools in the development of their plans and in engaging stakeholders (i.e., School Council) on an ongoing basis to provide assurance in advancing goals. Schools are obligated under the *School Councils Regulation* to provide school councils the opportunity to provide advice on the development of School Education Plans and AERRs, and to share results from provincial and local assessments.

Engaging with our stakeholders has been critical in the development and implementation of our Education Plan and AERR. We use a variety of methods to communicate and engage with stakeholders in the development of our Education Plan and in sharing results achieved to provide assurance. Effectively engaging stakeholders results in several benefits including being more responsive to local needs; increasing stakeholder understanding of education matters; and improving decision making.

Reviewing and analyzing provincial and local measures with stakeholders (students, staff and parents, school councils) is ongoing throughout the year and aligns with the [FSD Assessment and Survey Schedule](#), [AP 102 School Annual Education Plans and Annual Education Results Report](#) and [AP 118: Annual Assurance Actions](#). The use of both provincial and local measures provides a balanced and complete assessment of progress in advancing goals and achieving outcomes. Impact of strategies implemented to advance goals are evaluated and key insights identified (including strengths, areas for growth and next steps) by analyzing provincial and local measures on an ongoing basis throughout the year. This overview of data and key insights identified are added to the Annual Education Results Report throughout the year and shared with stakeholders (i.e., Board of Trustees and School Councils).
